On behalf of the Institute of Law, Economics, and Administration at the University of the National Education Commission in Krakow and the Organizing Committee, we cordially invite you to participate in the international academic conference "European Union -Present and Future in the Face of Crises and Reforms".

In recent years, the history of European integration has been characterized by a series of significant crises and overlapping adverse events. The problems in the Eurozone, migration pressures, Brexit, disputes with member states, the Covid-19 pandemic, and Russian aggression in Ukraine have merged to create a particularly challenging period in the journey towards

European harmonization

Considering the evolving political system of the European Union, where crisis response mechanisms frequently shape decision-making structures and establish precedents for future institutional actions it can be argued that European integration remains an ongoing and fluid endeavour. In the past several months, there has also been a renewed discussion about the future

of Europe and its constitutional structure.

In May 2022, the Conference on the Future of Europe concluded, during which four European citizens' panels presented over 150 recommendations in nine areas. The Conference recommended far-reaching treaty reforms, including the introduction of European referenda and the near-total abolition of national vetoes. In response to these proposals, the European Parliament adopted a resolution calling for the initiation of treaty reform procedures, which was met with negative reactions from thirteen governments, primarily those of the so-called 'new Europe'. On 22 November 2023, the European Parliament passed a resolution on the European Parliament's proposals for amending the Treaties [2022/2051(INL)].

In light of the above-outlined issues facing the European Union and the proposed constitutional changes, we invite you to engage in academic discussion, particularly in the following areas:

1. Constitutional-institutional facets and procedural functionings of the European Union.

The impact of the European Union on national orders, both from international and national perspectives; EU institutions and their relationships with member states; the outlook on the EU's enlargement. 3. Multicentrism of Legal Systems of Member States and the Constitutional Qualification

of the European Union.

 European integration in a constitutional context within member and candidate countries. Challenges in selected European policies, especially in the areas of climate and environment; healthcare and public health; economy, social justice and employment; digital transformation; migration; education, culture, youth, and sports.

6. Citizens of the European Union and the democratic legitimization of European integration.

7. The International role of the European Union.

The conference will be held on the 13th and 14th of June 2024 at the University of the National Education Commission in Krakow, located at Podchorażych St. 2, with the option of hybrid participation – both in-person and online via the MS Teams platform.
